Further, the ad-hoc promotion is subject to the following terms and conditions:-

1. That the Ad-hoc promotion is valid for initially one year or till regular arrangement is made or the date of superannuation, whichever is earlier.
2. That the Ad-hoc promotion will not confer any right on the official to claim for regular promotion to the post or any other service benefit.
3. That the period of service rendered on Ad-hoc basis will not be counted on officiating in higher grade for any purpose.
4. That the Competent Authority can terminate the interim arrangement at any time without assigning any reason and giving any prior notices.
5. That on conclusion of the disciplinary case/criminal prosecution which results in dropping of allegation(s) against any senior person, then the junior most officiating person will be reverted.
6. That the Ad-hoc promotion is subject to the condition that the official will successfully complete two week training from Delhi Jal Board Training Institute as and when the same is organised by the Assistant Commissioner (Training).
7. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.

All the above mentioned officials will continue to work at their present place of posting till further orders.
