Subject:-Discrepancy in Name and Father's Name of Muster Roll Worker in their Educational Certificate/ SLC/Birth Certificate.

The cases of following officials who were initially engaged as Beldar on M/Roll on Compassionate Ground vide O.O.No-85 dated 13.07.2016 and O.O.no-21 dated 24.02.2014 have been received in this office after duly verification/recommendation by AAO/DDO concerned, for their regularisation.

While going through the various document furnished by them in DJB related to their Declaration/Undertaking/Educational Qualification/Caste Certificate/I.D. Proof etc. for the purpose of their engagement to the post of Beldar on M/Roll on Compassionate Ground, it has been observed that the Name and father's name of individuals as mentioned in the orders issued AC(LW)'s and engagement letter differs with the name mentioned in Educational Certificate/SLC of the following muster roll workers.
