Delhi Jal Board in anticipation of confirmation of the minutes of the meeting held on 04.02.2021 vide its Resolution No. 1089, (Item No. Admn. 515) has approved the re-designation of the post of Assistant Engineer (Civil) & Assistant Engineer (E&M) by changing the nomenclature of the post only with the following conditions:-

1. Assistant Engineer (Civil) appointed against Recruitment Quota	Assistant Executive Engineer (Civil) {AEE(Civil)} after completion of 02 year regular service.
2. Assistant Engineer (E&M) appointed against Recruitment Quota	Assistant Executive Engineer (E&M) {AEE(E&M)} after completion of 02 year regular service.
3. Assistant Engineer (Civil) appointed under promotion quota from Junior Engineer (Civil)	Assistant Executive Engineer (Civil) {AEE(Civil)} after completion of 08 year regular service as AE(Civil).
4. Assistant Engineer (E&M) appointed under promotion quota from Junior Engineer (E&M)	Assistant Executive Engineer (E&M) {AEE(E&M)} after completion of 08 year regular service as AE(E&M).

The above change in the nomenclature of the designation of Assistant Engineers to that of Assistant Executive Engineers will be further subjected to :-

1. This change will be only in the nomenclature of the post and not for any other purpose.
2. No additional financial benefit either in form of pay scale, MACP or any allowance will be granted.
3. Their reporting officer will remain the same i.e any senior office under whom they are working or any higher officer as decided by the Competent Authority.
4. Their promotion to the post of Executive Engineer will be governed strictly as per existing notified Recruitment Rules.
5. The existing delegation of technical and financial powers delegated to them as Assistant Engineer shall remain unchanged.
