Dy.Dir (F&A) – I vide letter DJB/ACA/2010/38810 dated 29.04.2010 and further corrigendum 3. No. DJB/ACA/ (F&G)/2009/39737 dated 30.04.2010 advised that the officials concerned may be allowed to exercise their option, for fixation of pay after accrual of increment in the lower grade if any, under FR-22 (I) a (1) within one month of the issue of the order, regarding granting the financial up-gradation under the MACP/ACP Scheme. 4.

At the time of fixation of the pay of the above employees, the DDO will ensure that the officials have completed at least 10/20/30 years qualifying service, as the case may be, on the above dates without any break or unqualified service and they should be clear from vigilance

The financial up-gradation is merely placement in next higher grade pay and this does not 5. amount to functional/regular promotion or seniority benefit etc. in the grade.

All the conditions /stipulations contained in DOP&T OM dated 19.05.2009 be strictly followed while implementing the MACP Scheme in respect of concerned officials.
