

The functions to be discharged by the committee as circulated vide Office Order No. 01 dated 24.01.200 shall remain the same which are reproduced as under:-

- 1. To inquiry into the complaints of sexual harassment within the department and report the same to the State Complaint Committee within a specific time frame. For this purpose sexual harassment includes such unwelcome sexually determined behaviour (whether directly or by implication) as:
- a) Physical contact and advances.
- b) A demand or request for sexual favours.
- c) Sexually coloured remarks
- d) Showing pornography.

- e) Any other unwelcome physical verbal or non-verbal conduct of sexual nature.
- f) To recommend the action to be initiated in each case.
- g) To ensure that the victims or witnesses are not victimised or discriminated against. They shall also examine whether the victim should have the option to seek transfer of the perpetrator or their own.
- h) The Committee shall submit a detailed quarterly report of the complaints received and the action taken thereof, to the State Complaints Committee, with it's headquarter at I.P.Estate, New Delhi.
- i) Presiding Officer and Members shall hold office for **not** more than 3 years w.e.f. issue of this order.
- j) The Committee is vested with powers of civil Court under Code of Civil Procedure, 1908.
- k) The inquiry may be completed within 90 days.
