Further, the above arrangement is subject to the following term & conditions:

1. That as and when any Degree Holder(s) becomes available/eligible, **the Junior most Diploma Holder will be reposted back to his substantive post.**
2. That written undertaking (**as enclosed herewith**) is also required to be furnished by the above Diploma Holders, declaring that they will not demand any claim by individually/jointly or through any Court of Law w.r.t. this temporary arrangement being made in the interest of Department.
3. The entrustment of look after charge will be in their own pay scale of the post they are holding in substantive capacity.

4. It will not confer any right on the officers to claim for ad-hoc/regular promotion to the post or next higher grade or any other service benefits.
5. That the period of service rendered on look after charge will not count as officiating in the higher grade for any purpose/service benefits including seniority.
6. The Competent Authority can terminate the interim/stop gap arrangement at any time without assigning any reason and giving any prior notice.
7. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
8. That in reference to DoP&T's O.M. dated 15th June, 2018 bearing No.36012/11/2016-Estt(Res-i)(Pt-II), the entrustment of look after charge is also subject to final outcome of SLP(C) No. 30621 of 2011 pending before Hon'ble Supreme Court. Further, it is, also subject to final outcome of various Court Cases with similar subject matters/disputes i.e. Seniority, Reservation in Promotion and Reservation to migrants SCs/STs etc. Pending before Hon'ble Court(s) i.e. (i). WP(C) 522/2012 (DJB Vs. Mahender Singh), (ii). OA No.3295/2012 (M.K. Hans Vs. DJB), (iii). WP(C)1054/2017 (J.K. Singh Vs. DJB) (iv). WP(C) 9431/2017 (DJB Vs. M.K. Hans & Ors. (v). and any other case(s) if any.
