## INSTRUCTIONAL ORDER

## Subject: Preliminary Measures to Augment Revenue Generation

In order to provide metered connections with functional meter, rational use of water, to augment revenue generation, and reduction in non-revenue water, Delhi Jal Board vide Resolution No. 1140 dated 08.07.2021 has approved the following measures with immediate effect:-

- 1. All consumers in JJ/Resettlement Colonies & Villages will be sanctioned only metered connections and existing sanctioned unmetered connections will also be consiered as metered connections.
- 2. Installation of funcitonal meter will be made mandatory also in JJ Resettlement Colonies & Villages like consumeres in other areas of Delhi.
- 3. In case more than one dwelling units exists on same/different floors and different families are living, separate metered connection may be applied by residents and sanctioned by DJB for different dwelling units/floors and benefit of free water policy of 20 KL per month to each connection with functional meter may be availed by the consumers.
- 4. Existing policy of average billing @ 10 KL per month in JJ RSC and @ 20 KL per month in Villages is discontinued.
- 5. On a single connection, single benefit of free water policy of 20 KL per month will be given in JJ RSC.

In case functional meter is not installed, minimum average of 25 KL, or assessed average consumption on the basis of actual usages/number of families at different dwelling units using the same connection, whichever is higher, may be taken for billing purpose like other consumers of Delhi till functional water meter is installed.

All officers of revenue and maintenance divisions should give adequate publicity of instructions and encourage consumers to install functional meters and take separate connection for separate dwelling units.
