3. The competent authority can terminate the interim/stop gap arrangement at any time without assigning any reason and giving any prior notice.
4. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time
5. That on conclusion of the disciplinary case/outcome of court case/criminal prosecution which results in dropping of allegation(s) against any senior person, then the junior most officiating person will be reverted.
6. That the Ad-hoc promotion is subject to the condition that the official will successfully complete one week training from Delhi Jal Board Training Institute as and when the same is organized by the AC(Training).
7. That the Promotion is subject to outcome of Hon'ble High Court Judgement dated 23.08.2017 in WP(C) No. 3490/2010.
