APPOINTMENT LETTER

Consequent upon the recommendations of Selection Committee and further approval of Competent Authority, Group Captain Praveen Shukla S/o Late Sh. P.N. Shukla R/o B-13, Ground Floor, Swami Nagar South, New Delhi-110017 is hereby engaged as Consultant (Law) against a sanctioned vacant post of Chief Law Officer in Delhi Jal Board, on the following terms and conditions:-

- The engagement is on full-time basis and he would not to be permitted to take up any other assignment during the period of consultancy.
- The engagement is initially for a period of one year. However, it can be extended further subject to the satisfactory performance of the Consultant and depending upon the specific job and the time frame for its completion.
- He will be allowed to draw the remuneration as per Government of India, Ministry of Finance, Department of Expenditure O.M. No. F.03-25/2020-E-III-A dated 13.08.2020. A fixed monthly amount shall be admissible i.e. Last Pay minus Pension. No increment and Dearness Allowance shall be allowed during the term of the contract. His engagement as consultant shall not be considered as a case of re-employment.
- He will not be entitled to any other allowance such as House Rent Allowance, reimbursement of call charges of Residential Telephone/mobile, Transport facility, Residential Accommodation, Personal Staff etc.
- No Government vehicle shall be provided to the Consultant.
- No TA/DA shall be admissible for joining the assignment or on its completion. He will not be allowed foreign travel at Government expenses. However, he will allow TA/DA for his travel inside the country in connection with the official work, if any, as per entitlement.
- He will be eligible for 8 days leave in a calendar year on pro-rata basis, therefore, Consultant shall not draw any remuneration in case of his absence beyond 8 days leave in a calendar year (calculated on pro-rata basis). Also unavailed leave in a calendar year will not be carried forward to next calendar year.
- The engagement is of temporary nature and the engagement and the engagement can be cancelled at any time by the department without assigning any reason; and
- Engagement is subject to the condition that he is clear from Vigilance angle.

You are requested to submit your joining to Director (A&P) within 3 days of receipt of letter.
