Consequent upon the Selection for engagement on Compassionate Ground (Muster Roll) vide AC(LW) Office Order No-07 dated 28.02.2019 and further completion of pre-engagement formalities such as verification of educational certificate, caste certificate, verification of past antecedent from police and found Medically fit for the post of Peon-cum-Assistant Meter Reader (PCAMR) by Medical Officer In-charge, Delhi Jal board, Shri Sunil Kumar S/o Lt. Smt. Kranti W/o Budh Prakash, Safai Karamchari (C-133/2016) R/o H.No-195, Near Sanjay Gandhi School, Village Karhera, Mohan Nagar, District Ghaziabad (UP)-201007 is hereby engaged as Peon-cum-Assistant Meter Reader on Muster Roll on compassionate ground in Delhi Jal Board, subject to the following terms and conditions:-

- 1. That he/she will have to support the family of deceased/ medically retired ex-employee of Delhi Jal Board, in lieu of whom compassionate engagement is being given, failing which his/her services will be terminated without assigning any reason.
- 2. Verification of their Matriculation certificate, police verification, medical examination and caste certificate have already got done from respective issuing authorities/Officers. However, their educational certificates of higher education will be got verified by the DDO concerned within 3 months positively and a certificate will be sent to the administration that their certificates have been got verified and these certificates have been found genuine.
- 3. The engagement can be terminated at any time by a month notice by either side viz, by the appointee or the appointing authority without assigning any reason, unless that the tenure of the post against which he is appointed/ posted expire in which case the appointment shall be deemed to have expired on the date of expiry of the post without any notice.

- The engagement carries within the liability to serve in any part of the area under DJB.
 That his/her engagement is further subject to the satisfactory work & conduct during the period of
- 6. If he/she remains absent from duty for more than 30 days without any information/ permission, his/her services are liable to be terminated.
- 7. That he/she will be governed by the rules and regulations as are made to the other Muster Roll workers of Delhi Jal Board.
- 8. In case he/she is already employed, he/she should produce a No Objection Certificate/ relieving report from their previous employer.

Further, he is posted with EE(North -East)-I for further duties.
