



Dear Chief Secretary,

At the outset, I commend your efforts towards promoting e-governance solutions in your State/ UT. The implementation of online services for citizens benefits, holds a valuable lesson for the nation.

- 2. As we celebrate Azadi ka Amrit Mahotsav marking the 75<sup>th</sup> year of our country's independence, MoHUA has launched the National Urban Digital Mission (NUDM) to facilitate electronic delivery of municipal services to citizens across all towns and cities of the country. The Ministry looks forward to partnering and complementing in the significant efforts already made by you in this regard.
- 3. The rollout of Online Building Permission Systems (OBPS) has led to significant improvement of India's performance in World Bank's Ease of Doing Business Index. Moreover, a diverse range of e-governance solutions have been deployed in many States and cities, contributing to ease of living for India's urban residents. However, in order to achieve scale and speed in implementing such solutions in a systemic, integrated and sustainable manner, lot more efforts are needed. NUDM has been conceived in this background. It targets rollout of a bouquet of electronic e-governance solutions in 2022 towns and cities by 2022 and in all of them by 2025.
- 4. The open-source National Urban Governance Platform created to facilitate this journey will host key urban services such as: water and sewerage, birth and death registration, citizens' grievance redressal, online building permits, NOC, property tax, trade license, municipal accounting, and miscellaneous user fees. Along with this platform, the Mission will also make available empanelled and trained implementation partners, tools, templates, technical assistance to facilitate ease of roll out. At the core of Mission design is the choice-architecture built in the Technical Implementation Guidelines to enable States to drive the implementation as per their preferred modes. The Centre for Digital Governance at NIUA is working on behalf of the Ministry to roll out the Mission. You may reach out to Ms. Kakul Misra at cdg-contact@niua.org for any queries.
