The recommendation of the Screening Committee is subject to the following conditions:-

- The MACP scheme is implemented vide Govt. of India, Dept. Of Per. & Trg., OM No. 35034/3/2008-Estt. (D) dated 19.05.2009 and the pay and the date of increment would be fixed in accordance with clarification No. 2 of Department of Expenditure's OM No. 1/1/2008-IC dated 13.09.2008.
- 2. The pay and allowances of the incumbents will be fixed under the provisions of FR-22(i)(a)(1) subject to the terms and conditions contained in Director(A&P)'s circular No. DJB/AC(W)/ACP/99/7377 dated 30.11.99 and further clarified vide circular No. DJB/AC(W)/2000/29263 dated 05.11.2000 and DOP&T order No. 35034/3/2008-Estt(D) dated 19.05.2009, issued under the signature of the Dy. Secy. to the Govt. of India and including subject to implementation of penalty orders etc. while implementing the above MACP scheme by the DDO concerned.
- 3. Dy. Director(F&A)I letter DJB/ACA(F&G)/ACP/2010/38810 dated 29.04.2010 and further corrigendum No. DJB/ACA(F&G)/2010/39737 dated 30.04.2010. The official concerned may be allowed to exercise their option, for fixation of pay after accrual of increment in the lower grade if any, under FR-22(1)(a)(1) within one month of the issue of the order, granting the financial upgradation under the ACP/MACP Scheme.
- 4. At the time of fixation of pay of the above employees, the DDO will again confirm that the official have completed 10/20/30 years of qualifying service, as the case may be, on the above dates (vide colume-4) without any break or unqualified service and he should be clear from vigilance angle and his pay fixation is as per latest AC(G)-I Adminhistrative Office Order No. 96(Dist) dated 12.06.2017 whereever is applicable in terms of Resolution No. 400.
- 5. The financial upgradation is merely pl: ement in next higher grade pay and this does not amount to functional/regular promotion or seniority benefit etc. in the grade.
- The DDOs will verify that the employees that the employee recommended for financial upgradations were not under currency period of penalty, on the date from which financial upgradation has been recommended/allowed to him.
- Work charge staff transferred from DDA, if any, in the list shall be identified by the DDOs and processed separately as per rule.

This issues with the approval of Competent Authority.
