Security Agencies are requested to direct their Security Guards to report in the Offices of respective offices of ACEs as mentioned above for further duties/deployment under their jurisdiction. These Guards will be supervised by CSO,DJB and their remuneration/ wages will be dealt by the DDOs concerned under respective ACEs.

Security Agencies are also directed to strictly adhere to all the terms & conditions of Contract Agreement and especially the Clause 5 & 6. Accordingly, Security Agencies are directed as under :-

1. Furnish the certified copy of desired documents of Security Guards to CSO,DJB i.e. ESM ID Card, Discharge Book, PPO Book, Aadhar Card/PAN Card, Bank Pass Book along with copy of past antecedents verification done through police of all the civilian employees and affidavit from the Ex-Serviceman of the effect that he has never been arrested by the police and no case is pending against him in the court of law for any criminal activity and a certificate in this regard will be issued and same will be deposited with the department at the time of deployment or latest within one month of their deployment.
2. The details of the physical standard, standard educational qualification, age limit of the security guards being deployed shall have to be clearly stated by the Second party. In addition, the Second party will attach past track record of the satisfactory services of employees at least 01(One) years with a leading Govt./Semi-Govt./Public sector industry. This document should be duly authenticated by the employer.
