Further, it is subject to following terms and conditions:-

1. The ad-hoc promotion will not confer any right on the officer to claim for regular promotion to the post or any other service benefit.
2. The period of service rendered on ad-hoc will not count on officiating in higher grade for any purpose including seniority.
3. The Competent Authority can terminate the interim arrangement at any time without assigning any reason and giving any prior notice.
4. Other Conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
5. In reference to DoP&T's O.M dated 15<sup>th</sup> June, 2018 bearing No. 36012/11/2016-Estt(Res-i)(Pt-II), Ad-hoc promotion is subject to final outcome of SLP(C) No. 30621 of 2011 pending before Hon'ble Supreme Court and other court case, If any.
6. On conclusion of the disciplinary case/outcome of court case/criminal prosecution which results in dropping of allegation (s) against any senior person, then the junior most officiating person will be reverted.
7. In terms of relevant RRs dated 14.06.2015 all the above official(s) will also required to undergo one week's mandatory training successfully in DJB Training Institute as and when it is organized by the AC(Training)Cell.
