**Sub.: -Reimbursement of Medical facility to DJB Employees/ Pensioners/Family Pensioner and their dependent family members during the period of COVID-19 pandemic reg.**

Due to Corona virus disease (COVID-19) pandemic, the employees /Pensioners & their dependent of Delhi Jal Board were quarantine at home & took treatment from their nearest private doctors. Since most of hospitals, beds were occupied during the COVID-19 pandemic period, so employees were forced to undertake their treatment from private hospitals in emergency, as there was no alternate available or beds in panel hospitals were full. The severity of 2<sup>nd</sup> Wave of COVID-19 had put all medical infrastructure including government and empanelled hospitals under tremendous speed. Now they were facing great hardship of money which they had spent on their treatment.

On receipts of several request from the employees, the case was placed before the Competent Authority i.e. Member (Admn.), Delhi Jal Board who after considering the situation of COVID-19 pandemic has approved the reimbursement of OPD/IPD treatment of COVID-19 from non-panel hospital/diagnostic Centre & Private clinic without prescription etc. This reimbursement will be restricted to CGHS rates or actual rates, which ever is lower only. The above facility shall apply for treatment taken during the period 1<sup>st</sup> April 2021 to 31<sup>st</sup> July 2021.
