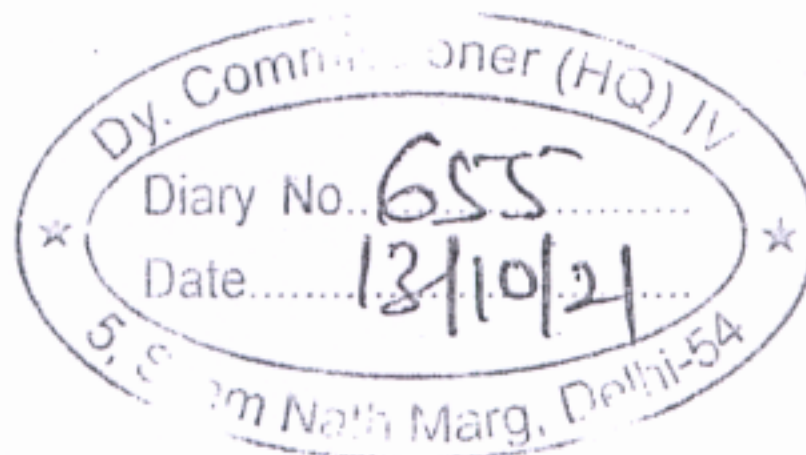
DDMA vide order no. F.60/DDMA/COVI-19/2021/463 dated 30.8.21 has allowed physical classes for class 9th to 12th with effect from 01.09.21. The CBSE first term examination for classes 10th and 12th is also likely to take place in the month of November 2021. Counselling services for students of classes 9th to 12th at this juncture is very crucial to help them deal with emotions such as fear of contagion, loss and grief, fear of losing loved ones, exam pressure and career anxiety which they may experience. Counsellors need to provide psychosocial support, empower families, and empower teachers about how to deal with a student who is in grief or experiencing anxiety along with their own emotional problems teachers themselves may be experiencing due to effect of this pandemic.

As per circular No. GMDC/COVID-19/2021/562 dated 3.9.21, on subject regarding immediate relieving of all TGTs/PGTs deployed for COVID-19 duties, the District Magistrates had been requested that all TGTs/PGTs who have been on COVID-19 related duties are to be relieved with immediate effect with directions to join back respective schools. Similarly, keeping in mind the importance of counselling in schools, EVGCs (lecturer/PGT) may also be relieved from COVID-19 duties.

Therefore, it is requested that all District magistrates may kindly relieve all EVGCs immediately, so that they may report back to their respective schools to take care of the mental health issues of the students.
