

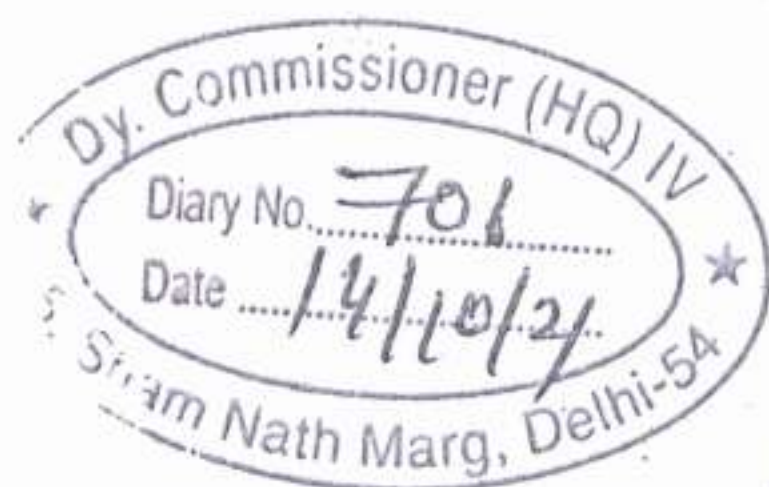
The licensees shall not be entitled to any compensation on account of any changes effected in the above list.
