Consequent upon selection through Delhi Subordinate Services Selection Board for the post of Physical Education Teacher under the Post Code-90/17 vide result notice no. 461 dated 30.06.2019 the following candidates were appointed purely on Temporary and provisional basis in the pay Scale of Rs. 9300-34800 with the Grade Pay 4600/- (Pre revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by him/her.

Further, the DSSSB vide No. F.187/Result/Physical Education Teacher/Int. Cell/DSSSB/2018-19/3856-66 dated 27.09.2019 in Supplementary Result Notice No. 518 in para no. 16 has mentioned that *the 03 candidates (mentioned at table no. 02) bearing Roll No. 2700014396, 2700000360, 2700005126 who were nominated earlier under UR category vide Result Notice No. 461 dated 30.05.2019 have been withdrawn for having lower marks in merit. Even though these candidates having equal marks to last selected candidates under UR category, but their candidature has been withdrawn and kept in waiting as per condition at sub para-vii of para-2 (Mode of selection) in Advt. No. 04/17 that "If there are two or more candidates in the same category having equal marks in the examination, the candidate older in age will get preference".*

The Directorate of Education, GNCTD has withdrawn the Provisional Appointment Order of these candidates vide letter No. DE.4 (7)/DRC/E-IV/PET/2019/2011-2015 dated 21.11.2019 with the approval of the Competent Authority.

The DSSSB again reviewed and declared the result of said roll nos. through Supplementary Result Notice No. 627 vide notice no. F.187/Result/Physical Education Teacher/Int. Cell/DSSSB/2018-19/1476-85 dated 12.06.2020. Further, the DSSSB vide its letter No. F.1(384)/DSSSB/P&P/2017/3876 dated 05.08.2020 vide para no. 18 has again consider these candidates under UR category as per their own merit has come down due to return of e-dossier with the direction to the user department should also take necessary corrective action accordingly.

Now therefore, considering the recommendations of the DSSSB vide letter No. F1(384)/DSSSB/P&P/2017/3876 dated 05.08.2020 in its para no. 18 and approval of Competent Authority is hereby conveyed and candidates as mentioned below are hereby directed to report to their respective place of posting latest by 30/01/2021 failing which his/her appointment shall stand cancelled without any further communication. The HOS concerned is hereby directed to get join the below mentioned candidates under the effect of this appointment order afresh and the joining of these candidates will be considered effective with the effect of their joining, the earlier joining of these candidates is no more effective. II) Verification of documents/certificate, NCTE Clarification, caste and category certificates will be carried out by the concerned DDE from concerned Institute/Universities/Authorities vide which the candidate has possessed the Educational Qualifications and other relevant documents, after joining the respective school. The Candidate(s) is/are hereby further directed to submit their joining report to the concerned HOS. Although, the first stage verification of correctness of the information/ Documents as furnished in application form and e-dossier/dossier vis-a-vis the original documents related to educational qualification, age, cast/category and other essential certificates has been carried out, as per instructions issued by the Govt. of India vide GOI MHA OM No. 2/29/54-RPS, 19/11/54 and GOI MHA OM No. 18011/2(s)/2016-Estt.(B)(i) dated 29/06/2016. However, if any discrepancy is noticed at later stage, the District/HOS Authority will report the same to HQ immediately.
