Cancellation of candidature in r/o Mr. Pawan Kumar Ruhella, Roll No. 110415000473 nominated to the post of PGT (Computer Science) Male under Post Code 150/17.

Whereas, Mr. Pawan Kumar Ruhella, (DOB-29/07/1981) Roll No.110415000473 was nominated by DSSSB for the post of PGT (Computer Science) Male against post code 150/17 as DCF candidate, vide letter no. F.1(401)/DSSSB/P&P/2017/4288 dated 02/11/2020 and Supplementary Result Notice No. 687 dated 12/10/2020. Accordingly an offer of appointment was issued to him for initial verification of documents vide this office memorandum of even No. dated 23-11-2020.

And whereas, on scrutiny of the dossier, it is found that Mr. Pawan Kumar Ruhella, (DOB-29/07/1981) Roll No.110415000473 is working in Kendriya Vidyalaya Sangthan which does not qualify the conditions of the DCF candidate as given in the advertisement No. 04/17 as under:

"Departmental candidate with at least three years continuous service in Govt. of NCT of Delhi/its Local or autonomous bodies."

Therefore, in view of the above fact, the candidature in r/o Mr. Pawan Kumar Ruhella, (DOB-29/07/1981) Roll No.110415000473 is hereby cancelled, as he does not qualify the conditions of the DCF candidate and the dossier is returned to the DSSSB
