As per the existing Recruitment Rules for the post of TGT Urdu under column no. 8(i) the required educational qualification is B.A. (Honours) in one of the Modern Indian Language (MIL) concerned or B.A. with MIL concerned as one of the Elective subjects from a recognized University having 45 percentage marks in aggregate with one additional language or one school subject at Degree level. The term elective as specified in Recruitment Rules of TGT/TGT MIL may be read as under:

"The candidate should have studied the subject concerned as mentioned in the RR's for at least 02 years during the Graduation course. The elective word may also include main subject as practiced in different Universities"

Whereas, Sh. Sh. AJAZ ASLAM, Roll No. 2510000939 has done Bachelors of Arts (B.A) from Jamia Millia Islamia University, wherein he has studied "Urdu" for only one year in Graduation another course of graduation done by the candidate from Uttarakhand Open University, he has studied single subject i.e BAUL without one additional language or one school subject at degree level.

Therefore, in view of the above facts and circumstances, the candidature of the **Sh.
