## ORDER

In pursuance of receipt of dossier from DSSSB vide letter No.F.1(230)/DSSSB/P&P/2013/3376 dated 26/02/2020 for appointment to the post of Librarian (Post Code 206/14) in Directorate of Education, Govt. of NCT of Delhi, this office had issued an offer of appointment to Ms.Sarika Bhatia (Roll No.3340000002) vide memorandum No. DE.4(9)/(72)/E-IV/2006/LIB/2020/2931 dated 04.09.2020 with the direction to report to E-IV branch, Directorate of Education, on 15.09.2020 for verification of requisite educational qualification testimonials to check eligibility in accordance with the RRs.but she failed to appear in this office on due date.

Further, Memorandum vide letter no. DE.4 (9)/(72)/E-IV/2006/LIB/2020/3034 dated 22.09.2020 was issued to Ms.Sarika Bhatia as one more opportunity to appear in person on 06.10.2020. After acceptance of offer of appointment by the candidate on 06.10.2020, it came to notice that there is deficiency in the documents submitted by the candidate.

Therefore, deficiency Memorandum was issued vide dated 15.10.2020, with the direction to submit a certificate from the issuing authority certifying that; "i) duration of the course (Certificate in Computing), ii) equivalency of the course with Computer Application" within 15 days from the date of receipt of this memorandum, failing which it would be presumed that the candidate do not have requisite qualifications as per RRs and the offer of appointment shall stand cancelled without any further communication.

In this response, the candidate Ms.Sarika Bhatia submitted a representation vides dated 26.10.2020 along with the mark sheet and certificate of above mentioned course i.e. Certificate in Computing. Ms.Sarika Bhatia stated that her certificate course is equivalent to a one year duration course in computers but no supporting document was submitted in this office.

Further, another deficiency Memorandum was issued vide dated 21.12.2020 with the direction to submit the supporting document in r/o of above mentioned deficiencies to this office by 04.01.2021, failing which it would be presumed that the candidate do not have requisite qualifications as per RRs and the offer of appointment shall stand cancelled without any further communication.

In this response the candidate Ms.Sarika Bhatia, submitted a representation vide dated 28.12.2020 along with a letter issued by IGNOU which is stating that Mrs Sarika Bhatia had completed her Certificate Programme (Certificate in Computing) in 2006 "the minimum duration of the programme was six months and maximum duration was 2 years"

Whereas, it is submitted that "Experience of Two years in Library/Computerisation of Library or <u>one year certificate in Computer application from a recognised institution or equivalent</u>" is required as the essential qualification for the post of Librarian as per RRs.

Whereas, the candidate **Ms.Sarika Bhatia** has given sufficient opportunities through deficiency memorandums to fulfill the requirements of the Recruitment Rules of the said post, but as per documents submitted by the candidate Ms.Sarika Bhatia does not fulfill the requisite essential qualification mentioned in the Recruitment Rules of the said post. Therefore the offer of appointment issued to **Ms.Sarika Bhatia** vide letter no.DE.4 (9)/(72)/E-IV/2006/LIB/2020/2931 dated 04.09.2020 is hereby stand withdrawn with immediate effect and her dossier is being returned to DSSSB for cancellation of candidature.
