Cancellation of Offer of Appointment to the post of Drawing Teacher Post Code 91/17.

Whereas, Rishi Raj Tomer, D.O.B. 07/03/1989, Roll No. 120209100895 has been nominated by the DSSSB for the post of Drawing Teacher against post code 91/17 in Directorate of Education, Govt. of NCT of Delhi vide result notice no. 617 dated 16/03/2020 and accordingly an offer of Appointment was issued to her vide this Directorate Memorandum dated 04/08/2020, 09/09/2020, 24/09/2020 and the final opportunity dated 16/12/2020

And whereas, Rishi Raj Tomer did not report in person on the scheduled date and time as given in the offer of appointment issued to the candidate vide letter of even no. dated 04/08/2020, 09/09/2020, 24/09/2020 and the final reminder of even no. dated 16/12/2020 and neither has intimated any reason to the Directorate for not reporting and nor has accepted the offer of appointment.


As per DoPT Office Memorandum No. 35016/2/93-Estt(D) dated 09/08/1995 wherein para 2, the following has been mentioned:-

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally.

Therefore, in view of the facts and circumstances as stated above and since the candidate has willfully chosen not to respond to the memorandums, this tantamounts to refusal to accept offer of appointment. Therefore, the candidature in respect of Rishi Raj Tomer is hereby cancelled and the dossier is returned to the DSSSB.
