And whereas, after successful verification of documents, **Sh Sh/Smt./Ms. HARSH SANDU** was appointed to the post of PGT (ENGLISH) Male vide appointment Order No.DE-2(7)/DRC(E-II)/PGT(ENGLISH)/Male/2019/1280 dated 12.06.2019 posting ID 20190062. Whereas, **Sh Sh/Smt./Ms. HARSH SANDU** has not joined the post till date in school allotted.
