**CANCELLATION OF OFFER OF APPOINTMENT AND CANDIDATURE
TO THE POST OF TGT (NATURAL SCIENCE) MALE UNDER POST
CODE - 135/17**

Whereas, Sh. Kamal Singh Rawat (DOB 21.01.1989) S/o Sh. G S Rawat, Roll No. 120213500845 under UR category has been nominated by the DSSSB for appointment to the post of TGT NATURAL SCIENCE (MALE) under post code 135/17 vide result notice No.455 dated 28/05/2019.

And whereas, as per the Recruitment Rule for the post of TGT Natural Science the essential educational qualification is "A Bachelor's Degree (Honorurs/Pass) or equivalent from a recognized University having secured 45% marks in aggregate, in two school subjects of which at least one out of the following should have been at the elective level :English,Mathematics,Natural/Physical Science, Social Science. (Main subjects for (i) TGT Natural Science/Phy. Science shall be Physics, Chemistry,Biology,Botany and Zoology."

And whereas, the said candidate has done Bachelor of Pharmacy from GGSIU,Delhi. The subjects studied by him in Graduation do not match with the subjects prescribed in the RRs. for the said post.

And whereas, the case of Sh. Kamal Singh Rawat was referred to Expert Committee constituted to ascertain the suitability of the candidature for the post as per the subjects studied by the him in the graduation vis-à-vis RR of the post.

And whereas, the Expert Committee considered the case of Sh. Kamal Singh Rawat and opined that a candidate will not be able to cater to the syllabi of the students reading from the class VI to X and found him unfit for the post of TGT (Natural Science).

And whereas, the matter of Sh. Kamal Singh Rawat was again referred to another Expert Committee to consider his candidature for the said post as per the educational qualification acquired by him in Bachelor of Pharmacy.

And whereas, the Expert Committee considered the subjects studied by Sh. Kamal Singh Rawat in B.Sc (Bachelor of Pharmacy) and found the candidate not suitable for the post of TGT Natural Science.



And whereas, the recommendation of expert committee was considered and accepted by the Competent Authority and approved to cancel the candidature of Sh. Kamal Singh Rawat for the post of TGT Natural Science.

Therefore, the candidature of the candidature of Sh. Kamal Singh Rawat (DOB 21/01/1989) S/o Sh., Roll No. 120213500845 under UR category Competent Authority has been cancelled and his dossier is returned to DSSSB.
