ORDER

Cancellation of Candidature for the post of Assistant Teacher (Primary)-15/19

Whereas, Sh. Sarnam Singh DOB 02.02.1995, Roll No. 11171100610 has been nominated by the DSSSB vide letter No. F.4 (348)/DSSSB/P&P/2019/3956 dated 25.08.2020 for appointment to the post of Assistant Teacher (Primary) (Post Code -15/19) in Directorate of Education, Govt. of NCT of Delhi. During the course of preliminary scrutiny of the candidate's dossier, it has been observed that the candidate has EWS Certificate of 04.06.2020, which is after the cut off date i.e. 15.10.2019 of advertisement No. 03/19 dated 05.09.2019.

Whereas it is clearly mentioned in the advertisement No. 03/19 dated 05.09.2019 that "Candidates who wish to be considered against reserved vacancies and /or to seek age relaxation, **must be in possession of relevant certificates (SC/ST/EWS/OBC/Non Creamy layer/PH/Educational/Experience etc.) issued by the competent/notified authority (in prescribed format) on or before the cutoff date (closing date of advertisement)** otherwise their claim for any category will not be entertained and their applications will be considered against Un-reserved (UR) category vacancies, if eligible otherwise. **The candidate has to select that particular category when applying online for the post. No request for change of category will be entertained at any later stage.** "

Therefore the Competent Authority has cancelled the candidature Sh. Sarnam Singh DOB 02.02.1995, Roll No. 11171100610, as the candidate does not fulfill the eligibility criteria as preset in said advertisement.
