Consequent upon selection through Delhi Subordinate Services Selection Board vide result notice no. 461 dated 30.06.2019, Sh. Amit Kumar, Roll No. 2700014396 was appointed to the post of PET under the post code 90/17, purely on Temporary and provisional basis in the pay Scale of Rs. 9300-34800 with the Grade Pay 4600/- (Pre revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by him. The Provisional Appointment and draw of pay and allowances for a period not exceeding 2 months is subject to medical examination within 2 months from the date of Provisional Appointment and if the candidate is subsequently found medically unfit his/her services shall be terminated after the expiry of the period of 1 month from the date of communication to him/her of the findings of the medical officer/board.

Further, the DSSSB vide its Supplementary Result Notice No.518, issued vide letter No. F.187/Result/Physical Education Teacher/Int.Cell/DSSSB/2018-19/3856-66 dated 27.09.2019, in para no. 16, has mentioned that the 03 candidates (mentioned at table no. 02) bearing Roll No. 2700014396, 2700000360, 2700005126 who were nominated earlier under UR category vide Result Notice No. 461 dated 30.05.2019 have been withdrawn for having lower marks in merit. Even though these candidates having equal marks to last selected candidates under UR category, but their candidature has been withdrawn and kept in waiting as per condition at sub para-vii of para-2 (Mode of selection) in Advt. No. 04/17 that "If there are two or more candidates in the same category having equal marks in the examination, the candidate older in age will get preference".

The Directorate of Education, GNCTD, in pursuance, had withdrawn the Provisional Appointment Order of these candidates, including that of Sh. Amit Kumar, vide letter No. DE.4 (7)/DRC/E-IV/PET/2019/2011-2015 dated 21.11.2019, with the approval of the Competent Authority.

Thereafter, DSSSB vide supplementary result notice no. 627 issued vide no. F.187/Result/Physical Education Teacher/Int. Cell/DSSSB/2018-19/1476-85 dated 12.06.2020 and subsequently vide its letter No. F.1(384)/DSSSB/P&P/2017/3876 dated 05.08.2020, again considered these 03 candidates for their fresh appointments, vide its para no. 18, under UR category with the direction to the user department to take necessary corrective action accordingly.

Accordingly, the Directorate of Education, GNCTD again issued the Appointment Orders in r/o these 03 candidates, vide order no. DE.4 (7)/DRC/E-IV/PET/2019/7590 dated 30.12.2020, with the approval of the Competent Authority.

Now, in partial modification of order no. DE.4 (7)/DRC/E-IV/PET/2019/7590 dated 30.12.2020, Sh. Amit Kumar s/o Subhash chander DOB 01.05.1989 hereby appointed purely on Temporary and provisional basis in relaxation of FR 10(4) to the Post Of PET Vide post code 90/17 in the pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4600 (Pre-revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by him/her. The Provisional Appointment and draw of pay and allowances for a period not exceeding 2 months is subject to medical examination within 2 months from the date of Provisional Appointment and if the candidate is subsequently found medically unfit his/her services shall be terminated after the expiry of the period of 1 month from the date of communication to him/her of the findings of the medical officer/board. Sh. Amit Kumar is hereby directed to report to his place of posting latest by 23/03/2021, failing which his appointment shall stand cancelled without any further communication. The HOS concerned is hereby directed to allow the below mentioned candidate to join, under the effect of this appointment order afresh, and the joining of the candidate will be considered effective from the effect of his joining and the earlier joining of the candidate is no more effective. This appointment is temporary and the above mentioned candidates will be on probation for two years and further subject to: I) Verification of character and antecedents by the DDE concerned. In case character and antecedents of the candidates is found not verified or any false information is given by candidate in self-declaration submitted by the candidate, the appointment shall be cancelled forthwith and other criminal/legal action will also be taken, as a consequence thereof. II) Verification of documents/certificate, NCTE Clarification, caste and category certificates will be carried out by the concerned DDE from concerned Institute/Universities/Authorities vide which the candidate has possessed the Educational Qualifications and other relevant documents, after joining the respective school. The Candidate(s) is/are hereby further directed to submit their joining report to the concerned HOS. Although, the first stage verification of correctness of the information/ Documents as furnished in application form and e-dossier/dossier vis-a-vis the original documents related to educational qualification, age, cast/category and other essential certificates has been carried out, as per instructions issued by the Govt. of India vide GOI MHA OM No. 2/29/54-RPS, 19/11/54 and GOI MHA OM No. 18011/2(s)/2016-Estt.(B)(i) dated 29/06/2016. However, if any discrepancy is noticed at later stage, the District/HOS Authority will report the same to HQ immediately.
