**CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (ENGLISH) MALE UNDER
POST CODE - 131/17**

Whereas, **Sh Soumya Raha, (DOB 19.08.1992) Roll No.2650007337** was provisionally nominated & selected by the DSSSB for appointment to the post of TGT (English)-Male, Post Code - 131/17 under UR category in Directorate of Education, Govt. of NCT of Delhi.

And whereas, as per the existing Recruitment Rules for the post of TGT (General), it has been prescribed under column no. 8 (iii) "**Working knowledge of hindi**".

And whereas, the case of **Sh Soumya Raha** was referred to Expert Committee constituted to ascertain the eligibility of the candidate as per the RR for the post as the not Hindi subject studied by him.

And whereas, the expert committee considered the case of Sh. Sh Soumya Raha with reference to the RRs for the said post and opined that "**Sh. Soumya Raha does not have Hindi at any level. Deficiency Memo to this effect was served to him which was received by him against acknowledgement on 16.09.2019. No objection has, till date, been filed against the deficiency (Hindi not studied) by the candidate. Accordingly, the committee unanimously decided to reject the candidature of Sh. Soumya Raha**".

And whereas, the recommendation of Expert Committee is placed before the competent authority and the recommendation has been approved thereby cancelling the candidature of Sh Soumya Raha.

Therefore, in view of the above facts and circumstances, the candidature of the **Sh Soumya Raha, (DOB 19.08.1992) Roll No.2650007337** for the post of **TGT English, Male (Post code 131/17)** stand cancelled, as the candidate does not fulfill the eligibility criteria as per the Recruitment Rules for the post and his dossier is returned to DSSSB.

**CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (ENGLISH) MALE UNDER
POST CODE - 131/17**

Whereas, **Sh. Monu Goyal, (DOB 02.04.1992) Roll No. 2650006690** was provisionally nominated & selected by the DSSSB for appointment to the post of TGT (English)-Male, Post Code - 131/17 under UR category in Directorate of Education, Govt. of NCT of Delhi.

And whereas, as per the existing Recruitment Rules for the post of TGT (General) under column no. 8 "**A bachelor's Degree (Honours/Pass) or equivalent from a recognised University having secured 45% marks in aggregate, in two school subjects of which atleast one out of the following should have been at the elective level English, Mathematics, Natural/Physical Science, Social Science.**
Note: Main subjects for TGT (Natural Science/Phy. Science/Economics/Business Studies/Sociology/Geography/Psychology)."

And whereas, the case of Sh. Monu Goyal was referred to Expert Committee constituted to ascertain the eligibility of the candidate as per the RR for the post as the candidate has done B.Com and he has not studied English for atleast 02 years in graduation. The candidate has studied English subject as additional subject.

And whereas, the expert committee considered the case of **Sh. Monu Goyal** with reference to the RRs for the said post and opined that "**Monu Goyal did not study English even for a single year during his B.Com. However, there are two more mark sheets to his credit in his record. As per these mark sheets, he studied English as 'Additional Subject' in BA part I, B.A. Part-II and B.A. Part-III. A closer look at these marks sheets reveals that Sh. Monu Goyal studied all the three parts of B.A. in one & the same year i.e. 2015. The Recruitments Rules mandate study of the concerned subject for at least, two years during graduation. Accordingly, the committee unanimously rejected the candidature of Sh. Monu Goyal as he did not study English (the concerned subject) for two years**".

And whereas, the recommendation of Expert Committee is placed before the competent authority and the recommendation has been approved thereby cancelling the candidature of **Sh. Monu Goyal**.

Therefore, in view of the above facts and circumstances, the candidature of the **Sh. Monu Goyal, (DOB 02.04.1992) Roll No. 2650006690** for the post of **TGT English, Male (Post code 131/17)** stand cancelled, as the candidate does not fulfill the eligibility criteria as per the Recruitment Rules for the post and his dossier is returned to DSSSB.

And whereas, as per the existing Recruitment Rules for the post of TGT (General) under column no. 8 " **A bachelor's Degree (Honours/Pass) or equivalent from a recognised University having secured 45% marks in aggregate, in two school subjects of which atleast one out of the following should have been at the elective level English, Mathematics, Natural/Physical Science, Social Science.**
Note: Main subjects for TGT (Natural Science/Phy. Science/Economics/Business Studies/Sociology/Geography/Psychology)."

And whereas, the expert committee considered the case of Mohammad Arif with reference to the RRs for the said post and opined that "**Mohammad Arif studied 1) English Literature 2) Education and 3) English Language in all the three years of graduation. Obviously, his only subject, other than English, is 'Education', which is not included in list of school subjects. Therefore, the committee is of the unanimous opinion that the candidature of Sh. Mohammad. Arif may be rejected**".

And whereas, the recommendation of Expert Committee is placed before the competent authority and the recommendation has been approved thereby cancelling the candidature of Mohammad Arif.

Therefore, in view of the above facts and circumstances, the candidature of the **Mohammad Arif, (DOB 10.04.1985) Roll No. 2650000139** for the post of **TGT English, Male (Post code 131/17)** stand cancelled, as the candidate does not fulfill the eligibility criteria as per the Recruitment Rules for the post and his dossier is returned to DSSSB.
