MEMORANDUM

WHEREAS, an offer of appointment vide this office memorandum dated 03.05.2019 to the post of Special Education Teacher (Post Code-87/17) was sent to Sh. Vasu Dev Sharma (Roll No. 2290000053) with the direction to appear in person in this office on 17.05.2019 for documents/testimonials verification.

AND WHEREAS, on the day of document's verification, the candidate being Government employee, a memorandum dated 17.05.2019 was served upon him to submit 'No Objection Certificate (NOC)' and some other deficient documents.

AND WHEREAS, as regards NOC, he submitted a letter dated 31.05.2019 addressed to him, from Northern Railway, Central Hospital, Basant Lane, New Delhi-110055. As per the letter dated 31.05.2019, the criminal proceedings under Section 4 of POCSO Act vide FIR No. 492 dated 23.10.2018 at PS SGM Nagar, FBD are pending against him and parallel departmental proceedings initiated vide SF-2 No. 724-E/Med/Vasudev Sharma/HA/NRCH/NDLS dated 07.02.2019 are also pending against him. It has also been stated that "However, taking a liberal view, the Competent Authority has accorded permission strictly provisional, subject to out come of further criminal/departmental proceeding to appear for document verification and other further process."

AND WHEREAS, Police Station SGM Nagar Faridabad vide letter dated 31.01.2021 has informed that the accused Vasudev Sharma S/o Ramjilal Sharma was arrested on 25.10.2018 & produced before the court in the aforesaid case and the said case is sub-judice in the court.

NOW THEREFORE, since he could not submit NOC till date despite lapse of a period of more than one & half years, his candidature to the post of Special Education Teacher (Post Code-87/17) is hereby cancelled and his dossier is being returned to the DSSSB.
