Cancellation of Offer of Appointment to the post of Physical Education Teacher Post Code 90/17.

Whereas, **Ms. VIJAY LAXMI, D.O.B. 24/06/1987, Roll No. 2700001063** has been nominated by the DSSSB for the post of Physical Education Teacher against post code 90/17 in Directorate of Education, Govt. of NCT of Delhi vide result notice no. 461 dated 30/05/2019 and accordingly an offer of Appointment was issued to her vide No. F.DE.4(7)/DRC/E-IV/PET/2019/4073 dated 04/11/2020.


After document verification, a deficiency memo regarding clarification of educational qualification was issued to the candidate vide letter dated 18/11/2020, as the candidate possessed M.P.Ed (Physical Education) without obtaining the required qualification of B.P.Ed.

As per existing Recruitment Rules for the post of PET (90/17), the candidate does not possess the required qualification of B.P.Ed.

Therefore, the offer of appointment No. F.DE.4(7)/DRC/E-IV/PET/2019/4073 dated 04/11/2020 in r/o Ms. VIJAY LAXMI, D.O.B. 24/06/1987, Roll No. 2700001063, to the post of Physical Education Teacher, against post code 90/17, is hereby withdrawn and the candidature stands cancelled.


