MEMORANDUM

And whereas the candidate, **Mr. Alok Kumar Jaiswal** remained absent on the above date. The candidate given another opportunity vide Memorandum No. DE.4(14)/04/Recruitment. Drawing/E-IV/ 2017/PF-F/2188 dated 21/01/2021 with the direction to appear on 29/01/2021 for document verification and acceptance of offer of appointment, failing which it will be presumed that **Mr. Alok Kumar Jaiswal** is not willing to accept the offer of appointment and proceedings for cancellation of candidature for the post of Drawing Teacher (Post Code-208/14) will be initiated.

And whereas **Mr. Alok Kumar Jaiswal** again remained absent on 29/01/2021. The candidate was given **final opportunity** vide memorandum No. DE.4(14)/04/Recruitment Drawing/E-IV/ 2017/PF-F/2606 dated 09/02/2021 with the direction to appear on 19/02/2021 for document verification and acceptance of offer of appointment, failing which it will be presumed that **Mr. Alok Kumar Jaiswal** is not willing to accept the offer of appointment and proceedings for cancellation of candidature for the post of Drawing Teacher (Post Code-208/14) will be initiated. But **Mr. Alok Kumar Jaiswal**, again remained absent on the date given in the final opportunity.

Therefore, the offer of appointment bearing no. DE.4(14)/04/Recruitment Drawing/E-IV/ 2017/PF-F/371 dated 06/01/2021 issued to **Mr. Alok Kumar Jaiswal** (Roll No.: 12805191), is hereby stand withdrawn. Further candidature of **Mr. Alok Kumar Jaiswal** is cancelled for the post of Drawing Teacher (Post Code 208/14) and dossier of the candidate is returned to DSSSB for further necessary action at their end.
