ORDER

Cancellation of Offer of Appointment to the post of PGT (Computer Science) Female
Post Code 151/17


Whereas, **Ms. JYOTI**, D.O.B. 24-10-1993, Roll No. 110215100145 has been nominated by the DSSSB for the post of PGT (Computer Science) Female against Post Code 151/17 vide letter No.F1(401)/DSSSB/P&P/2017/2128 dated 10-04-2019 vide Result Notice No. 379 dated 23-03-2019 and accordingly an Offer of Appointment was issued to her vide this Directorate Memorandum dated 06-08-2019, the candidate was appointed vide appointment order No: DE-2(13)/DRC(E-II)/PGT(COMP.SC.)/FEMALE/2019/1625 and directed to report to her place of posting. The candidate seek extension for joining and the same was granted vide order No: DE-2(13)/DRC(E-II)/PGT(COMP.SC.)/FEMALE/2019/759 dated 11/02/2021 by mentioning in the order that if the candidate did not joined the place of posting within stipulated time period "*her candidature shall stand cancelled without any further communication*".

1. And Whereas, **Ms. JYOTI** neither joined the place of posting nor intimated any reason to the Directorate for not reporting to the place of posting.
2. As per DoPT Office Memorandum NO. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment".

Therefore, In view of the facts and circumstances as above and since the candidate has willfully chosen not to join the place of posting and since it has been mentioned in the extension order that if the candidate did not joined the place of posting within stipulated time period "*her candidature shall stand cancelled without any further communication*". Since the candidate did not turn up to join the place of posting and neither communicated further, the candidature in respect of **Ms. JYOTI (Employee id: 20193157)** is hereby cancelled and the dossier returned to the DSSSB.


