In pursuance of receipt of dossier from DSSSB (GNCTD) vide letter No.F.1(230)/DSSSB/P&P/2013/3376 dated 26/02/2020 for appointment to the post of Librarian (Post Code 206/14) in Directorate of Education, Govt. of NCT of Delhi, this office had issued an offer of appointment to Mr. Saket Kumar (Roll No.3340000239) vide memorandum No. DE.4(9)/(72)/E-IV/2006/LIB/2020/2930 dated 04.09.2020 with the direction to report to E-IV branch, Directorate of Education, on 15.09.2020 for verification of requisite educational qualification testimonials to check eligibility in accordance with the RRs. but he failed to appear in this office on due date.

Further, Memorandum vide letter no. DE.4 (9)/ (72)/E-IV/2006/LIB/2020/3035 dated 22.09.2020 was issued to Mr. Saket Kumar as one more opportunity to appear in person on 06.10.2020. Mr. Saket Kumar has accepted the offer of appointment.

After the acceptance of offer Mr. Saket Kumar was sent for medical verification and subsequently after the candidate i.e. Mr. Saket Kumar found medically fit, he was issued posting order 20210049 vide no. F.DE-4(9)/72/E-IV/2006/LIB/2020/724-729 dated 16/03/2021(posting ID 20210049) with the direction to join R.K.Puram, Sector-2-Sarvodaya Co-ed Vidyalaya- 1719013 by 30/04/2021 and uploaded the same on the official website of the Directorate. But the candidate did not join the said post nor requested for extension within the last date of joining.

And whereas the date of Joining in r/o Sh. Saket Kumar, Emp ID 20210275 is further extended upto 15/07/2021 but Sh. Saket Kumar has failed to join during the specified period of time.

Therefore, the offer of appointment bearing no.DE.4(9)/(72)/E-IV/2006/LIB/2020/2930 dated 04.09.2020 issued to Mr. Saket Kumar (Roll No. 3340000239), for the post of Librarian under post code-206/14, is hereby stand withdrawn and cancelled with immediate effect and his dossier is being returned to DSSSB (GNCTD).
