**CANCELLATION ORDER**

**Cancellation of Offer of Appointment to the post of PGT (Hindi) Female Post Code 111/17**

**Smt. Surekha Meena**, D.O.B. 07.08.1993, Roll No. 121811104140 has been nominated by the DSSSB for the post of **PGT (Hindi) Female** against Post Code **111/17** vide letter F.1 (395)/DSSSB/P&P/2017/4585 dated 05.01.2021 as per supplementary result notice no. 703 dated 10.11.2020 and its corrigendum no. 5184-93 dated 11.12.2020 and accordingly Offer of Appointment was issued to her vide this Directorate Memorandum dated 08.02.2021.

And whereas, **Smt. Surekha Meena** did not appear for verification of documents to the post of PGT (Hindi) Female despite offer of appointment and subsequent reminders issued to her as under:
