Consequent upon selection through Delhi Subordinate Services Selection Board for the post of TGT SOCIAL SCIENCE (Male) under Post Code 137/17 and with the prior approval of the Competent Authority, the following candidate is hereby appointed purely on Temporary and provisional basis to the Post of TGT SOCIAL SCIENCE (Male) in the pay Scale of Rs. 9300-34800 with Grade Pay 4600/- (Pre revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by him/her. The Candidates has been medically examined by the Govt. Hospital and declared FIT vide their individual report placed in their respective dossier. In case of OBC candidate, the appointment will be provisional. At the time of joining, the OBC candidate will have to submit an undertaking to concerned Head of the School/Office that "It is hereby undertaken that the information furnished by me are true and correct and the OBC certificate is as per provisions contained in DSSSB Advertisement No. 04/17. In the event of OBC Certificate being found false or detected incorrect or incomplete at any stage or any other ineligibility being detected after the appointment, my candidature/appointment is liable to be cancelled/terminated automatically without any notice and action may be taken against me by the Department as per Rules". Subsequently, the DDE concerned may seek clarification from Revenue Authorities in case of OBC Candidate. If the OBC certificate of the candidate concerned is found invalid, his/her candidature will be terminated with immediate effect. The candidate is hereby directed to report to his/her respective place of posting latest by 31.08.2021 failing which his/her appointment shall stand cancelled without any further notice and his/her dossier will be returned to DSSSB.
