ORDER

CANCELLATION OF OFFER OF APPOINTMENT AND CANDIDATURE TO THE POST OF TGT
(MATHS) – MALE, UNDER POST CODE-133/17

Whereas, Sh. Chandan Kumar (DOB 12.02.1991) S/o Sh. Digvijay Kumar, Roll No. 111013300286 under UR category has been nominated by the DSSSB for appointment to the post of TGT Maths (Male) under post code 133/17 vide result notice No. 420 dated 30.04.2019.

And whereas, as per the Recruitment Rule for the post of TGT (Maths) the essential educational qualification is "A Bachelor's Degree (Honours/Pass) or equivalent from a recognized University having secured 45% marks in aggregate, in two school subjects of which at least one out of the following should have been at the elective level: English, Mathematics, Natural/Physical Science, Social Science. (Main Subjects for (i) TGT natural Science/physical Science shall be physics, Chemistry, Biology, Botany and Zoology."

And whereas, the case of Sh. Chandan Kumar was referred to Expert Committee to ascertain the 2nd School Subject studied by him in Graduation, which is an essential educational qualification for the post of TGT (Maths).

And whereas, during the meeting of the Expert Committee, it was found by the Committee that the candidate Sh. Chandan Kumar has done his Graduation from Eastern Institute for Integrated Learning in Management University (EILMU), Sikkim during the year 2009-2011. The Expert Committee opined that "the candidate has done B.Sc. – Mathematics in 2011, from EIILM University of Sikkim, is need to be verified either Govt. of Sikkim or UGC, whether the course done by the candidate is valid, as the University has been derecognized since – 2015, before issued of appointment."


And whereas, UGC, Ministry of Education Government of India informed through a detailed letter wherein it was mentioned, among other things, that "Director (Higher Education), Human Resource Development Department, government of Sikkim may validate the degrees of 2009-2010 in three disciplines i.e. B.A. (Hospitality & Tourism), BCA and MBA for students admitted within the territorial jurisdiction of State of Sikkim based on the admission records available with the university's Sikkim campus/State Government. Degrees in other disciplines except in three as specified in preceding lines and beyond academic year 2009-2010 shall not be valid."

And whereas, Dy. Director/APIO, Higher Education, Education Deptt., Govt. of Sikkim informed that "Bachelor of Science (Mathematics) is not a UGC/DEC recognized course for EIILM University, Sikkim. As such the enclosed degree (photocopy) of Chandan Kumar, bearing enrolment no EIILMMU/09/S4749 is not valid/genuine".

And whereas, the matter of Sh. Chandan Kumar was considered by Competent Authority, Dte. of Education, GNCTD for consideration of the candidature for the post of TGT (Maths)-Male, Post Code 133/17 and the candidature of the candidate cancelled for the said post by the Competent Authority on account of Degree/Certificate of Graduation done from EIILM University, Sikkim during January, 2009 to December, 2011 being not Valid/Genuine .

Therefore, the candidature of Sh. Chandan Kumar (DOB 12.02.1991) S/o Sh. Digvijay Kumar, Roll No. 111013300286 under UR category is hereby cancelled for the post TGT (Maths)-Male, Post code 133/17 with the prior approval of the Competent Authority and his dossier is returned to DSSSB.
