**ORDER**

**Cancellation of offer of Appointment and candidature to the post of TGT( Social Science)**  
**Female Post Code 138/17**

Whereas, **Ms. Kailashi Devi Meena, D.O.B. 10.07.1993, Roll No. 110613800826** has been nominated by the DSSSB for the post of **TGT Social Science (Female)** against **Post Code 138/17** vide letter No. F.1(389)/DSSSB/P&P/2017/4613 dated 11.01.2021 vide Result Notice No. 725 dated 10.12.2020 and accordingly an Offer of Appointment was issued to her vide this Directorate Memorandum dated 01.03.2021, the second opportunity was given to her vide office memorandum dated 29.06.2021 and third opportunity was given to her vide office memorandum dated 15.07.2021 and Memorandum of Final Opportunity was given to her vide office memorandum dated 06.09.2021.

And Whereas, **Ms. Kailashi Devi Meena** did not report in person on the scheduled date and time as given in the offer of appointment issued to her vide letter no. DE.3(14)/DRC/E-III/TGT/Social Science/Female/2019/805 dated 01.03.2021, second offer of appointment issued to her vide letter no. DE.3(14)/DRC/E-III/TGT/Social Science/Female/2019/3091 dated 29.06.2021, third Reminder vide letter no. DE.3(14)/DRC/E-III/TGT/Social Science/Female/2019/3164 dated 15.07.2021 and final reminder vide letter no. DE.3(14)/DRC/E-III/TGT/Social Science/Female/2019/3392-93 dated 06.09.2021 neither she has intimated any reason to the Directorate for not reporting and nor accepted the offer of appointment.

As per DoPT Office Memorandum NO. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally."

Therefore, In view of the facts and circumstances as above and since the candidate has willfully chosen not to respond to the memorandums dated 01.03.2021, second, third and final offer of appointment dated 29.06.2021, 15.07.2021 and 06.09.2021. The Competent Authority has cancelled the offer of appointment/candidature bearing no. DE.3(14)/DRC/E-III/TGT/Social Science/Female/2019/805 dated 01.03.2021 in respect of **Ms. Kailashi Devi Meena, D.O.B. 10.07.1993, Roll No. 110613800826** and the dossier returned to the DSSSB.


