ORDER

Cancellation of Candidature for the post of Physical Education Teacher-90/17


Sh. Amit Kumar (Emp ID-20210224), DOB 01/05/1989, Roll No.2700014396 was nominated by DSSSB for the post of Physical Education Teacher, under post code-90/17 in Directorate of Education, Govt. of NCT of Delhi vide result notice no. 461 dated 30/05/2019 and accordingly offer of Appointment was issued to him vide No. F.DE.4 (7)/DRC/E-IV/PET/2019/3305 dated 27/09/2019.

And, whereas, after successful verification of documents, Amit Kumar was appointed to the post of Physical Education Teacher, under Post Code-90/17, vide appointment Order No.DE.4(7)/DRC/E-IV/PET/Pt.File/2020/7748-57, posting ID 20210039 dated 22/02/2021 and extension was also granted to him upto 06/08/2021 vide letter dated 24/06/2021 and final opportunity was given to him to join the allotted school by 31/08/2021 vide order dated 23/08/2021. His representation dated 01.09.2021 for further extension was considered by the Competent Authority but not acceded to. Whereas, Sh. Amit Kumar did not join the post till 31/08/2021 in the school allotted to him.

Therefore, in view of the above facts and circumstances, since the candidate has willfully chosen not joining the school allotted to him, the provisional appointment order issued to **Sh. Amit Kumar** (Emp ID-20210224), DOB 01/05/1989, Roll No.2700014396 is hereby cancelled and the dossier of the candidate returned to DSSSB for further necessary action at their end.
