ORDER

Sub: Re-allocation of school to the Guest Teacher (Fresh Panel-2020-21).

Whereas, DoE advertised vacancies for the post of TGT (Maths, Science and English) and PGT (English, Maths, Physics, Biology, Chemistry, commerce and Economics), EVGCs and Special Educators vide public notice dated 25.11.2020.

And whereas, order dated 29.12.2020, 01.01.2021, 06.01.2021, 11.01.2021, 14.01.2021, 21.01.2021, 01.03.2021 and 18.03.2021 have been issued by the department regarding allocation of schools to the selected candidates as per vacancies shown on the MIS Module.

And whereas, when the below mentioned selected applicant reported to the allocated school, it came to her notice that there is no vacancy for the concerned post in the school. Now school is re-allocated to the selected candidates as per details given under:

Now, therefore, the above mentioned short listed candidate is hereby directed to report to the HOS of the School mentioned against her name within 05 working days, failing which it shall be presumed that candidate is not willing to join her duty and chance of deployment will be given to the next candidate in the merit list. The candidate is further directed to bring the following documents (in original and one self-attested photocopy):


1. Printout of online filed application form bearing signature and date.
2. 10th class mark sheet and certificate showing date of Birth.
3. 12th Class Mark sheet and certificate.
4. Graduation mark sheet of every year and degree/provisional Certificate.
5. B. Ed/Diploma Mark Sheet of every year and degree/provisional Certificate.

6. SC/ST/OBC/EWS Certificate (if applicable), issued by the Competent Authority.
In case of OBC, the OBC Certificate should be issued by GNCT of Delhi.
7. Disability Certificate (if applicable).
8. Creamy layer certificate (in case of OBC candidates).
9. Two photographs
10. Photo Identity proof (Preferable Aadhar Card)
11. Address proof.

Further, concerned HOS is directed to verify the above mentioned documents carefully within 07 working days positively and in case of discrepancy/ variation of the data filled in the application form by the candidates vis-a-vis the original documents produced by the candidate, he /she shall not be joined and her case shall be referred to E-V branch through the concerned District office. After ensuring the genuinely of the documents, the applicant shall be joined in the school. In case of any clarification regarding Recruitment Rules for the concerned post, the HOS shall consult and seek advice of the Deputy Director of Education (E-III Branch).

Further, engagement of Guest Teachers is a stop arrangement and does not confer any right for permanent joining. The Guest teacher shall be relieved once a permanent teacher joins the school.
