- 11. Address proof.

Further, concerned HOS is directed to verify the above mentioned documents carefully within 07 working days positively and in case of discrepancy/ variation of the data filled in the application form by the candidates vis-a-vis the original documents produced by the candidate, he /she shall not be joined and her case shall be referred to E-V branch thorough the concerned District office. After ensuring the genuinely of the documents, the applicant shall be joined in the school. In case of any clarification regarding Recruitment Rules for the concerned post, the HOS shall consult and seek advice of the Deputy Director of Education (E-III Branch).

Further, engagement of Guest Teachers is a stop arrangement and does not confer any right for permanent joining. The Guest teacher shall be relieved once a permanent teacher joins the school.
