The Candidate have been medically examined by the Govt. Hospital and declared FIT vide his/her individual report placed in their respective dossier. Subsequently, the OBC verification report will be checked by the DDE concerned. If the OBC certificate of the candidate concerned is found invalid, his/her candidature will be terminated with immediate effect. The candidate is hereby directed to report to his/her respective place of posting latest by 09/12/2021 failing which his/her appointment shall stand cancelled without any further communication.
