Consequent upon selection through Delhi Subordinate Services Selection Board for the post of TGT SOCIAL SCIENCE (MALE) under Post Code 118/12 and with the prior approval of the Competent Authority, the following Candidate is hereby appointed purely on Temporary and Provisional basis to the Post of TGT Social Science (Male) in the pay scale of Rs. 9300-34800 with Grade Pay 4600/- (Pre revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by him. The Candidate has been medically examined by the Govt. Hospital and declared FIT vide his individual report placed in his respective dossier. In case of OBC candidate the appointment will be provisional and at the time of joining, the candidate will have to submit and undertaking to concerned Head of the school/office that "It is hereby undertaken that the information furnished by me are true and correct and my OBC certificate is as per provisions contained in DSSSB Advertisement No. 118/12. In the event of OBC certificate being found false or detected incorrect or incomplete at any stage or any ineligibility being detected after the appointment, my candidature/appointment is liable to be cancelled/terminated automatically without any notice and action may be taken against me by the Department as per rules". Subsequently, the OBC verification report will be checked by the DDE concerned. If the OBC certificate of the candidate concerned is found invalid, his candidature will be terminated with immediate effect. The candidate is hereby directed to report to his respective place of posting latest by 13.12.2021 failing which his appointment shall stand cancelled without any further communications.
