ORDER

CANCELLATION OF CANDIDATURE FOR THE POST OF TGT ENGLISH (FEMALE) POST CODE 132/17

Whereas, Ms. Sarita D.O.B. 15.03.1984, Roll No. 2660023069 was provisionally nominated & selected by the DSSSB for appointment to the post of <u>TGT ENGLISH (FEMALE)</u>, Post Code - 132/17 under SC category in Directorate of Education, Govt. of NCT of Delhi.

And Whereas, during the preliminary scrutiny of dossier of candidate it has been found that candidate has studied English only one year in her Graduation. The candidate has done BA Honrs(Political Science) & English studied in two semester only. Accordingly a deficiency memo dated 24.10.2019, was issued to the candidate with the direction to submit the reply along-with the supporting document, however, the candidate failed to submit any formal supporting document with her reply.

And Whereas, as per the existing Recruitment Rules for all post of TGT (General), it has been mentioned in the Advertisement No.04/17 N.B- "The candidate should have studied the subject concerned as mentioned in the RR's for at-least 02 years during the Graduation course. The elective word may also include main subject as practiced in different universities" vide order No DE.3 (15)/DR/E-III/Elective/2017/4371 Dt. 05.07.2017 issued by Directorate of Education.

And whereas, the case of Ms. Sarita, was referred to An Expert Committee constituted to ascertain the eligibility of the candidate as per the RR for the post and the Educational Qualifications acquired by the candidate.

And Whereas, the recommendation of the Expert Committee has been approved by the Competent Authority, Directorate of education GNCT of Delhi.

And whereas, the expert committed considered the case of Ms. Sarita with reference to the RRs for the said post and opined that "In the Corrigendum issued by Establishment-III Branch(With the approval of the Competent Authority) vide No. 4371 Dt. 05.05.2017, it has been clarified that the candidate should have studied the subject concerned as mentioned in RRs for at least 02 years during the Graduation Course". However, a perusal of the dossier of Ms. Sarita reveals that she did B.A. honours in Political Science from Delhi University wherein she studied English only for one year which renders her ineligible for the post. Hence, rejected".

Therefore, in view of the above facts and circumstances, the candidature of the Ms. Sarita Roll No. 2660023069 under SC category, for the post of <u>TGT ENGLISH (FEMALE)</u>, <u>Post Code - 132/17</u> stand cancelled, as the candidate does not fulfill the eligibility criteria as prescribed in said advertisement and the dossier is returned to the DSSSB.
