Further, the candidate has sought exemption from Medical examination by virtue of being already in Government Service. In case of OBC candidate the appointment will be provisional at the time of joining the candidate will have to submit an undertaking to concerned Head of the School/office that "It is hereby undertaken that the information furnished by me are true and correct and the OBC certificate is as per provisions contained in DSSSB advertisement number 04/17 and in the event of being found false or detected incorrect or incomplete at any stage or any ineligibility being detected after the appointment, my candidature / appointment is liable to be cancelled / terminated automatically without any notice and action can be taken against me by the department as per Rules'. Subsequently, the DDE concerned may seek clarification from Revenue authorities in case of OBC Candidate. If the OBC certificate of the candidate concerned is found invalid, his/her candidature will be terminated with immediate effect.
