
ORDER


Attention is invited to orders referred to above, whereby HoDs and Administrative Secretaries were required to seek relaxation from the Council of Ministers and Finance Department (depending on the amount involved in the expenditure proposals) for incurring expenditure even within their delegated powers.

2. The matter has been examined, and it has now been decided that HoDs and Administrative Secretaries will not be required to seek relaxation from the Council of Ministers or the Finance Department for incurring expenditure in accordance with the Delegation Order issued by the Finance Department vide O.M. No. F.20/08/2019/AC/jsfina/2575-2674 dated 07/08/2019. Proposals which are, however, not covered within delegated powers, as per FD OM dated 07/08/2019 shall continue to be sent to the Finance Department/EFC/Council of Ministers, as the case may be.



3. Administrative Secretary of the Department concerned will continue to remain authorized to incur COVID-19 related expenditure, for which prior concurrence of the Finance Department is required in terms of Finance Department O.M. dated 7/8/2019 without referring the proposal to the Finance Department as per Order No. F.(23)/Fin.(Estt.III)/2016-504-521 dated 24/3/2020.

4. This issues with the approval of Hon'ble Deputy Chief Minister/finance Minister.
