In pursuance of provision made for reforms in Targeted Public Distribution System (TPDS) under section 12(1) read with 12(2)(b) & 12(2)(d) of National Food Security Act 2013, distribution of food grains of National Food Security Act'2013 (NFSA) and Pradhan Mantri Garib Kalyan Anna Yojna (PM-GKAY) and any other scheme for ration card holders/NFS beneficiaries is allowed to be made through e-PoS from all fair price shops in Delhi with One Nation One Ration Card (ONORC) plan facility from the month of July 2021 allocation. Following instructions will be followed while distribution of ration through e-PoS device: -

- 1. Distribution of ration of NFS, PM-GKAY and any other scheme implemented through FPSs for ration card holders/NFS beneficiaries from the month of July 2021 allocation will be made only through e-PoS devices and its associated accessories in Delhi.
- 2. The Stock register at each FPS shall be signed by the concerned FSO/FSI before opening of sale through e-PoS. Distribution made through e-PoS will not require to be entered in manual sale register.
- 3. Distribution of ration under Portability shall be permitted in all Fair Price Shops connected to e-PoS devices. Beneficiaries may take their ration from any e-PoS enabled FPS in Delhi.
- 4. Distribution under ONORC scheme will be allowed through all e-PoS enabled FPSs in Delhi as per Gol orders issued time to time. This facility will be allowed to all migrant beneficiaries under national portability, who have been identified under NFSA in their parent state.
- 5. Beneficiaries would contact the HELPLINE No.1967 for their grievance, if any of not getting ration through e-PoS or may contact concerned circle FSO.
- 6. FPS owner would contact: 9717198833/9911698388 for any device related issue.
- 7. The information of the HELPLINE No.1967 or 1800-11-0841 numbers for Technical support of e-PoS device by BEL shall be displayed on each FPS shop.
- 8. The vulnerable family only having old age persons (above 65 years) and differently abled persons as per Gol letter No.5(3)/2017-PD-III dated 01/02/2018, may be identified through FPS owner for special facilitation to such family as per above letter.

IT Branch of Department of F&S will provide necessary technical support to the fair price shop holders while using e-PoS device. All Zonal Assistant Commissioners are hereby directed to ensure the distribution of ration to the NFS beneficiaries and migrants through e-PoS device and ONORC.
