And whereas, the retail licenses for consumption "off" the premises in form L-6, L-6FG, L-7, L-7FG, L-8, L-9, L-10, L-22, L-23, L-23F and M&TP Licenses (L-4, L-5, L-25, L-26, L-34, L-35, DD-9, DD-10, DD-11, P-2, P-3, P-4, P-5, P-6, Authorization Permit) were renewed after taking approval from Competent Authority for a period of three months commencing from 01.04.2021 on payment of proportionate license fee vide order no F.No. (9)/Policy/Extn. Excise/2020-21/215, dated 16.03.2021.

And whereas, the Competent Authority approved the extension of validity of existing L-1/L-1F/L-2 licences for the sale of liquor brands registered as per approved terms and conditions for 2020-21 at their existing price upto 30.06.2021 on payment of proportionate pro-rata license fee vide order no F.No. (9)/Policy/Extn. Excise/2020-21/217, dated 17.03.2021.

And whereas, the retail licenses for consumption "on" the premises in form L-15/L-15F, L-16/L-16F were renewed for a period of three months commencing from 01.04.2021 on payment of proportionate license fee vide order no F.No. (9)/Policy/Extn.Excise/2020-21/1077, dated 19.03.2021.

And whereas, the retail licenses for consumption "on" the premises in form L-17/L-17F, L-18/L-18F and L-19/L-19F were renewed for a period of three months commencing from 01.04.2021 on payment of proportionate license fee vide order no F.No. (9)/Policy/Extn.Excise/2020-21/1078, dated 19.03.2021.

And whereas, the retail licenses for consumption "on" the premises in form L-28/L-28F and L-29/L-29F were renewed for a period of three months commencing from 01.04.2021 on payment of proportionate license fee vide order no F.No. (9)/Policy/Extn.Excise/2020-21/1079, dated 19.03.2021.

And whereas the Government of NCT of Delhi has approved the new Excise Policy 2021-22, which is likely to be implemented in next three months.

Therefore, in order to ensure smooth and uninterrupted supply of authorized liquor in Delhi, it has been decided to extend/renew all existing licenses for a further period of 3 months upto 30.09.2021, commencing from 01.07.2021. Renewal is subject to payment of proportionate license fee on or before 30.06.2021 for the said period of 3 months, on the same terms and conditions upon which extension/renewal upto 30/06/2021 was granted vide above-mentioned orders, provisions of Delhi Excise Act/Rules, renewal procedure laid down in earlier orders issued by the Department.

Concerned branches shall issue separate fee order wherever required.

This issues with the approval of the Competent Authority.
