ORDER

Please refer to this department's order No F(9)/Policy/Extn./Excise/2020-21/612 dated 10/09/2021 whereby all government liquor vends in form of L-6/L-6FG/L-6FE were allowed to continue to operate beyond 30/09/2021 till 16/11/2021 i.e. one day prior to the scheduled date of commencement of business for new licenses granted in form of L-7 subject to payment of pro-rata proportionate license fee, to ensure that the supply of liquor is maintained in Delhi during the transition period .


Accordingly, all 4 Government Corporations viz. M/s DTTDC, M/s DSIIDC, M/s DSCSC and M/s DCCWS are hereby directed to deposit the pro-rata proportionate license fee for the period w.e.f. **01/10/2021 to 16/11/2021 (47 days)** in respect of their L-6 vends on the basis of following calculation :

**License Fee for L-6 license @ Rs. 51510/- (each vend)**

**License Fee for L-6/FG License @ Rs. 5150/- (each vend)**

Renewal is subject to payment of above proportionate License fee on or before 30/09/2021 on the same terms and conditions upon which extension/renewal upto 30/06/2021 was granted vide above mentioned order dated No. F.(9)/Policy/Extn./Excise/2020-21/215 dated 16/03/2021.
