1. Brief facts of the complaint

1.1 Ms. Anju Kumari filed a grievance petition before Public Grievances Commission aggrieved by her non-admission in 11th Class (Regn.No.20200096499) in Badarpur School (ID No.19252498).

2. Facts emerged during the proceedings.

2.1 HOS, Govt. Girls Sr.Sec.School No.3, Badarpur, New Delhi filed an action taken report. It is stated in the report that “*Anju Kumari was allocated GGSSS No.1(1925042), Badarpur for admission in Class XI by the Zonal Level Admission Committee. She was admitted in GGSSS No.1 (1925042), Badarpur. Report issued by HOS of said school is attached.*

Hence, her admission could not be done in GGSSS No.3 (1925248), Badarpur. “

A letter dated 16.01.2021 from the complainant has also been filed along with the report wherein the complainant has stated that she got admission in XIth Class in September and she is satisfied with the studies. Further, she has no grievances against GGSSS No.3, Badarpur or the Education Department and she has withdrawn her complaint.

2.2 The complainant is not present. However, she telephonically informed the Commission that she has no grievances against the School authorities and the matter with regard to her admission has been resolved to her satisfaction.

3. Directions :

3.1 In view of the action taken by the respondent department and the confirmation from the complainant that her matter has been resolved and she has no grievances against the School Authorities or the Education Department, the case stands disposed of in the Commission.
