#### 1. Brief facts of the complaint

1.1 Shri Y.P. Purang has filed a grievance petition before Public Grievances Commission, demanding for re-fixation of pay/revision of the pre 2006 retiree Principals to maintain parity with the post 2006 Principal whose pay/pension re-fixed based on the VI CPC's recommendations of granting an upgraded prerevised pay scales of Rs.12000-16500 on pay band 3 + grade pay of Rs.7600/-

#### 2. Relevant facts emerging during the hearing

2.1 Shri Arvind Kumar Arora, Pairvi Officer/TGT appearing on behalf of Dy.Director of Education, Distt NW-B filed an action taken report, which is a copy of the letter dated 01.12.2020 addressed to Shri Y.P. Purang, complainant. It has been stated in the letter that "Regarding fixation of pay/revision of the pre-2006 retiree Principals, SLP No.16321/2018 titled Rajendra V/s Uol tagged with SLP (C) No.29383/2018 titled Ramphal Vs. UOI are pending in the Hon'ble Supreme Court of India and next date of hearing in the matter is 07.12.2020.

In the light of the submissions of the DCA(North) and observations of the Competent Authority(P&PW), as per letter dated 20.02.2020 by Under Secretary to the Government of India, DoPT, the District authorities are not competent to grant fixation of pay/revision to all the pre-2006 retiree officials.

2.2 Copy of the action taken report/letter dated 01.12.2020 is enclosed with this order for ready reference of the complainant.

### 3. <u>Directions:</u>

3.1 Since the matter is subjudice, the matter stands closed in the Commission. Director (Education), GNCT of Delhi, is advised to take appropriate action as per orders of the Hon'ble Court. The complainant, if he so wishes, may file appropriate representation before the Competent Authority for redressal of his grievances.
