**1. Brief facts of the complaint**

1.1 Sh.Rajiv Mittal filed a grievance petition in PGC against charging and collecting around Rs.4,000/- from every student/parent during lockdown period in the name of Management Funds and Pupils Welfare Funds (Rs.240/-) for the whole year by Harcourt Butler Sr.Sec.School, Mandir Marg, New Delhi-110001.

**1. Relevant facts emerging during the hearing**

2.1 No action taken report filed. However, Dy.Director of Education, Zone-26, GNCT of Delhi, stated that the inquiry with regard to issues raised in the grievance petition is under process and the matter is under consideration of the Director(Education) for decision.

2.2 Heard the representative appearing on behalf of the complainant. The Commission notes that none of the

parents/students of the said School has made any complaint in this regard to the Commission. Further, the complainant is not directly affected by the issues raised by him and filed the petition without any documentary proof. Furthermore, the issues raised in the petition are already being dealt with by the respondent department at appropriate level. He has no bonafide.

**3. Directions of the PGC**

3.1 In view of the above, the grievance petition of the complainant is dismissed in the Commission.

3.2 The complainant is advised not to file such petitions in the Commission in future.
